Please be advised that Southeast Asia Cement Holdings, Inc. (Seacem), a major shareholder of Lafarge Republic, Inc. (LRI or Company), has disclosed that in a meeting on 19 February 2013, its board of directors has authorized the sale of:

- i) up to 1,113,893,336 shares of its LRI shares of stock to its major shareholder, Calumboyen Holdings, Inc. and to South Western Cement Ventures, Inc. (an existing major

shareholder of LRI) or other related party, under terms and conditions to be agreed between the parties provided that the price shall be on an arms length basis. These sale(s) to related parties will be submitted to the Seacem shareholders at a special stockholders meeting to be held on March 27, 2013.

ii) up to 100 million of its LRI shares to the public (including qualified institutional investors) in one or several tranches, as Seacem may deem fit,


provided that the sum of the LRI shares sold under i and ii above shall not exceed the aggregate 1,163,089,336 LRI shares which Seacem owns.
