
We refer to the Power Supply Agreement dated 4 July 2012 between Masinloc Power Partners Co., Ltd. (Masinloc) and Lafarge Republic, Inc. (LRI), and the Contract for the Sale of Electricity dated 9 July 2012 between Trans-Asia Oil & Energy Development Corporation (Trans-Asia) and LRI, each providing for the supply of electricity to LRI's cement manufacturing plants in Norzagaray, Bulacan and Taysan, Batangas for a period of 5 years commencing on 26 December 2012. Please be informed that on 4 November 2013, pursuant to the implementation of the Retail Competition and Open Access in the electric

power industry, LRI entered into separate supplemental agreements with Masinloc and Trans-Asia, whereby the parties agreed to supplement and amend their respective July 2012 contracts to cover the supply of electricity to LRI's cement manufacturing plant in Teresa, Rizal, under agreed terms and conditions.
